COURSE TITLE:	CRITICAL INFRASTRUCTURE SECURITY & RESILIENCE AWARENESS / AWR-213			
OVERVIEW:	<p>This one-day course will introduce participants to the key terms, policies, guidance and preparedness efforts required to safeguard the nation's critical infrastructure. Discussion also includes the risk management framework, federal critical infrastructure security & resilience, information sharing programs and programs for individual actions.</p> <p>Primary focus will be on local preparedness efforts as they relate to the national approach to critical infrastructure security and resilience. This understanding will enable stakeholders to address local planning within a common framework addressing the mission of prevention, protection, mitigation, response, and recovery.</p> <p>This is the <u>first</u> of a series of four infrastructure protection courses being presented through December, 2019. Students successfully completing all four courses* will obtain the "TEEX Infrastructure Protection Certificate".</p> <p><u>*Four core-courses scheduled:</u></p> <ul style="list-style-type: none"> - AWR-213 / Dec. 3, 2019 - MGT-310 / Dec. 4-5, 2019 - MGT-315 / Dec. 10-11, 2019 - MGT-414 / Dec. 12, 2019 <p>Each of the above is a separate course and may be taken irrespective of the others; however, for those wishing to obtain the certification, all four will need to be successfully completed - whether on these dates or at some other time in the future.</p>
